Assessment Invoices to be Mailed in Mid-January & Continuing Budget Process

The Board of Directors recently approved the assessment levels at \$1,495 for lots with sewer and \$1,375 for lots without

sewer for the 2024-2025 fiscal year. Invoices should be posted and sent to all Property Owners in mid-January. When you receive your assessment invoice, please review the information and balance shown on the invoice. If you have any questions, please call us at the Association Office at 815-849-5209.

You will continue to have two payment options. You can make full payment on or before March 31, 2024, to receive a \$30 discount on lots with sewer service, or a \$25 discount for lots without sewer. You can also make three installment payments, with 50% of the assessment due on or before March 31, 2024, and second and third installment payments equal to 25% of the assessment due on or

before May 31, 2024, and July 31, 2024.

Work on the budget process will continue into March, when the final budget schedule is approved by the Board of Directors. Staff and the Board will work on updating our five-year operating plan, our reserve plans and prepare monthly budget projections for 2024-2025. Any changes or adjustments are subject to Committee and Board review and approval prior to presentation to the Membership. If anyone is interested in obtaining more information about the budget process, please contact the Association Office to schedule an appointment with the Executive Director.

OTHER NEWS, NOTES & PROJECTS

- The Service Center underground storage tank and gas pump project was completed, and the new gas pumps were open for use on November 22, 2023.
- Comfort Stations were closed for the winter except for 3, 10, 17 & 25, which will remain open for the winter.
- Steel roof installation was completed on Comfort Station 25.
- Approximately 80 new road signs were installed during late fall early winter. A total of about 160 signs have now been installed with the third and final phase of the road sign replacement project completed next year.
- The Section 4 fishing pier was installed.
- Installation of the new deli line cases has begun at the General Store.
- Cabin Fever Festival is planned for Saturday, February 3, 2024.
- The Chicago RV and Camping Show is scheduled for February 15 – 18, 2024 at the Donald E. Stephens Convention Center in Rosemont, IL.

04-200-1223 Package Handling Policy Owners may receive packages via the Woodhaven Association address. The following guidelines have been established for receipt of a packages:

- 1. Packages must be addressed to 509 Lamoille Rd., Sublette, IL 61367.
- 2. Packages must be addressed to an Owner of Record as shown on the deed, and the Section/Lot of the Owner must be listed in the address.
- 3. Packages weighing 60 pounds or less will be accepted. Any packages received over 60 pounds will be rejected at time of receipt and returned to carrier, at no cost to the Association.
- 4. The Association will log the name of the person picking up packages. The Association is not responsible for the package(s) once they are logged out.
- 5. Owners are responsible for the removal of packages from the Association office area.
- 6. Packages are expected to be picked up within a week. Packages remaining 30 days after receipt will be returned to the carrier, at no cost to the Association.
- 7. Non-conformance to any part of this policy will result in rejection/return of the package(s) to the carrier without notice, and at no cost to the Association. Rejection/Return of packages to the carrier will be noted in the Association log.

Snow & Ice Control Procedures

- The decision to plow snow and/or apply ice control materials to Woodhaven's roads will be made by Maintenance Department personnel and will be based on a variety of factors including: forecasted depth of snow and temperatures, time of day, and scheduled activities and events.
- When blinding conditions exist, all equipment will be pulled off the roads until it is safe to operate.
- Woodhaven Drive East and West, Greenbriar Trail, Mayfair Trail, and Cranhurst Trail are priority roads. These roads are plowed and/or spread with chips in their entirety first. Secondary roads and cul-de-sacs are plowed only after the priority roads are tended.
- Specific problem areas will be handled as soon as possible after the Maintenance Department has been notified. Emergencies should be directed to the Main Gate by calling 815-849-5915.
- Property Owners are required to remove vehicles completely from the road at all times during the snow removal process. Citations will be issued to violators.
- Plows may make several passes in order to widen the roads. "Windrows" are unavoidable.
- Plows will not be lifted at any entrance to individual driveways.
- Maintenance personnel are prohibited from plowing private driveways; clearance of driveway entrances is the responsibility of the Campsite owner.
- Association personnel are prohibited from using Woodhaven vehicles for the purpose of pulling or towing owners or quest's vehicles.







Resource(ful) Information - DEER EDITION

Whitetail deer are an important part of Woodhaven, that is why the Association has taken a proactive approach toward looking at the risks involved with the growing deer herd. As fall has comes to a close and winter is upon us, we wanted to provide some valuable information regarding the deer population along with some basic facts and the potential concerns in general. We would like to provide you, the Property Owners, with as much information and current data as possible. The Association formed a Deer Management Committee in the spring of 2023 to assess the deer herd. The committee's mission is to collect, review and analyze data/information/recommendations provided by local agencies, municipalities, along with field work by staff related to Woodhaven's deer population, then make a recommendation to the Board of Directors based on this data for the purpose of maintaining a well-balanced and healthy deer herd at Woodhaven.



Since 2019 we have sent off a total of 4 does to be tested for CWD. Thus far all of which have come back negative. We will continue to monitor the deer health and send them to be tested when symptoms deem it necessary.



Illinois Cumulative CWD-Infected Sections - August 15, 2023

Epizootic Hemorrhagic Disease (EHD)

- Signs appetite loss, loss of fear of humans, weakness, excessive salivation (not foaming), respiratory distress, feverish, swelling in head/neck/tongue/eyelids, lack of consciousness, blue appearance of tongue.
- Vector-borne viral disease transmitted by insects when a deer is bitten. (midges, gnats, etc.)
- Often fatal but those that survive develop an immunity to the virus.
- Water levels (dry or flooding) can affect outbreaks in areas.
- There is no effective management for EHD. The number of infected deer will decrease after a hard frost or freezing temps.
- Not as much of a concern as CWD; EHD cannot be transmitted from deer to deer.
- 1 deer was found in July of 2023 that showed symptoms of EHD.

Deer counts



Over-population potential impacts:

- Research has shown that deer can cause a reduced diversity of plants, virtually eliminate forest understory, and reduce the reproductive potential of rare plants. This alteration of plant communities also encourages the growth of exotic species such as garlic mustard that outcompete other native plants such as trilliums, orchids, and ginseng.
- Over browsing, which reduces the regeneration of trees, allows more sunlight to reach the forest floor, thus changing the plant species composition.
- · Greater risk of deer/vehicle accidents
- · Higher risk of disease transmission
- Loss of habitat for ground nesting birds and small mammals



Ice-Fishing Season Coming

The ice-fishing season is once again close at hand. As the ice begins to form on the lakes across northern Illinois, ice anglers will be anticipating catching bluegills, crappies, trout, and other species through the holes carved into the ice. This winter pastime is a means of enjoying the outdoors when temperatures fall well below the freezing mark. A fair number of anglers come out to Woodhaven's lakes to ice

fish on a regular basis through the winter. As with fishing in open water, there are precautions one must take to ensure a safe trip.

The first and most important thing to do is find out the ice conditions on the body of water you intend to fish. In most instances, one must visit the lake or pond to personally assess ice conditions. The Association staff do not assess ice conditions daily to provide assurance of "safe" ice. Some general guidelines based on newly formed ice, which is stronger than older ice, are as follows:

- 2 inches- safe for walking (not recommended)
- 4 inches fishermen plus equipment
- 5 inches-snowmobiles
- 8 to 12-vehicles

Vehicles & snowmobiles are not allowed on Woodhaven Lakes! This just gives a rough idea of the load bearing strength of ice at different thicknesses.

There are many factors that cause ice to weaken, some of which are fluctuating air temperatures, precipitation, currents under the ice, geese, and fluctuating water levels. The presence of aeration/circulation devices on the lakes should be noted and steered well clear of as the current produced by the water movement causes ice to thin.




Figure 1 Icesafety picks should be a must for all ice anglers in the event one falls through the ice.

As a precaution, aeration and circulation devices will be operating on all lakes this coming season. Even though the ice may seem 'safe' around these devices, anglers are cautioned to stay well away from them to avoid the danger of falling through the ice. These devices create current under the ice. Be sure to carry a pair of

safety ice picks in the event you fall through the ice(Figure 1). These picks allow an angler to pull himself or herself up onto the ice otherwise it is impossible to grip the ice to get out of a hole after falling through. Before stepping onto the ice, the above factors and precautions should be heeded to avoid a catastrophe. Do not take for granted that ice is safe on a given day during the season.

In addition to the precautions relating to ice conditions, please continue to follow daily catch limits while out on the ice. Heavy winter ice fishing pressure affects fish populations, so practice good conservation to ensure healthy fish populations in the future.

I came across the following article, "Fishy Colors", in the Illinois American Fisheries Society newsletter recently and thought anglers would have interest in it. I know some of you have come across these color variations while out on the water over the years.

Fishy Colors

JIM GARAVAGLIA, IDNR

Fish exhibit a wonderful array of colors and patterns that have evolved over long periods of time. The coloration and pattern may provide camouflage from predators or prey, or they may help attract a mate during spawning season. The various colors of a fish are generally produced by three main pigments: brown/ black (melanin), red (erythrin), and yellow (xanthin). Iridophores also play an important role in coloration by refracting light to create white/silver, blue, and green. But what happens when the genes that express these colorations mutate, or simply aren't expressed? Albinism occurs when a fish has a complete loss of all pigmentation. Albino fish will be completely white in coloration, and their eyes will look pink or red due to the lack of pigmentation in the eye. Leucism occurs when a fish has a partial loss of pigments. Leucistic fish will be pale or have patchy pale coloration (often referred to as piebald when patchy). Depending on the pigments remaining, a leucistic fish may have xanthism (only yellow pigments remain) or erythrism (only red pigments remain). Melanism occurs when melanin is overproduced, causing the fish to be darker than usual, often completely black. Not all abnormalities in coloration are simply up to genetic chance though. Blotchy Bass Syndrome, a condition where hyperpigmented skin lesions are found on black bass species, was recently found to be associated with a virus.

For Those That Left Watercraft at Storage & **Common Areas**

Several watercrafts remained on lake storage areas as of December 1. These were picked up and placed in storage until owners come forward to claim them. Rules and Regulations state that watercraft must be removed from common areas and designated lake storage areas by December 1. Letters will be sent out to those with proper identification, unfortunately not all had identification as required. If you know that you left a watercraft at a storage area without identifying numbers, please contact me at the number below. Owners will be required to pay a \$20 pickup fee as well as \$5/month storage fees to claim the watercraft. DAILY CATCH LIMITS AND RULES - 2023

- Woodhaven Lake largemouth bass harvest up to 3 fish under 12 inches and "Catch & Release" on fish 12 inches and greater.
- Bass Lake largemouth bass harvest up to 3 fish under 12 inches and "Catch & Release" on fish 12 inches and greater.
- Pine, Sunset, Black Oak, Hidden & Bluegill lakes 1 largemouth bass/day, 14 inch minimum length limit.
- All Lakes 15 fish combined catch limit on bluegill and redear species.
- All lakes 15 fish limit on crappie
- All Lakes 4 fish limit on channel catfish. 6.
- 7. All lakes - return grass carp to the lake
- 8. All lakes - No limit on common carp, bullhead, and green sunfish species.
- All lakes NO MINNOWS: using live minnows can introduce unwanted species/ organisms into our lakes.
- No harvesting of turtles. This is geared mainly towards snapping turtles in which populations have been declining in the State over the years due to overharvest.
- 11. 2 poles and line only in the water at a time for all the lakes on property. With this restriction, anglers would be allowed to have multiple poles but only 2 lines in the water at a given time.
- 12. No unattended fishing devices allowed at any time on any of the lakes. Unattended devices can cause mortality to fish and turtles that should be released if undersize as well as interfere with boaters using the lakes.
- 13. No trotline or jug fishing on any of the lakes. Given our fisheries are recreational, I believe these devices are damaging to our fisheries and interfere with boaters using the lakes.

January tends to be the coldest month of the year! According to an article by USA Today, the coldest month of the year is January in 45 US states while December and February cover the rest. The average low temperature in Illinois during January is 10.9°F! The coldest temperature in Illinois history was documented on January 31, 2019, when the town of Mount Carroll hit a low of -38°F (only 45 miles northwest of Woodhaven). You might remember that week of polar vortex cold. This record bested the prior record of -36°F on January 5, 1999, in Congerville Illinois, a town between Peoria and Bloomington/Normal.

While we don't enjoy these cold temperatures, it's an opportunity to find unique nature art! During chilly weather, we can find beautiful works of art by nature in the form of ice. Ice is water in its frozen solid form, freezing at 32 degrees Fahrenheit. When water freezes quickly it creates cloudy ice and when frozen slower it can create clear ice. Icicles are one form of ice art that can change within minutes as it melts and changes over time. On lakes or puddles, we can find ice with leaves frozen in it or even various bubbles and frosty shapes.



This January try creating your own nature ice art. One way is to create an ice wreath. Start by gathering nature items: leaves, berries, pinecones, pine needles, acorns, or orange peels. You will need a cake pan or bundt pan to freeze your water and nature items in. Place the items in the pan and cover with water. If using a cake pan, place a piece of yarn or ribbon on the edge to be able to hang your ice wreath later; with a bundt pan you can tie the ribbon around the wreath once frozen. Next, place your pan outside and let nature freeze it for you (if it is not cold enough to freeze, place it in a freezer overnight). Depending on outside temperatures, it could take 3-15 hours to freeze. Once frozen, hang in a tree outside and watch the changes happen!

NATURE NUGGETS: LET'S TAKE A CLOSER LOOK AT LOCAL NATURE!

Bald Eagles (Haliaeetus leucocephalus) are semi-common birds found around the Woodhaven Lakes area. This majestic bird has been the emblem of the United States since 1782. Bald Eagles typically live closer to water, in coastal areas, rivers, and large lakes as well as open country and mountains. In Illinois, these eagles can occasionally be found in almost every county during winter and around the northern part of the state year-round. The name 'bald' eagle comes from the old Englis word "balde," meaning white.

Bald Eagles take five years to become fully adult in their looks. Immature birds begin mostly dark in color. Over the next five years, those feathers change to add the white feathers of the head and tail until fully white. They have a wingspan of around 6-feet in width and weigh only 6.5 to 14 pounds.



Eagles build large nests made of tree branches near the top of trees. They reuse these nests every year, adding more branches and increasing the size of the nest. Nests average 5-6 feet wide and 2-4 feet tall. The largest known Bald Eagle nest was in St. Petersburg Florida. It was 9.5 feet wide and 20 feet tall! Some eagle nests can weigh more than 1-2 tons! Nesting can start as early as January to April around northern Illinois where they lay 1-3 eggs. These eggs are dull white and both adults take turns incubating the eggs for 34-36 days.

Fish is the core food source for the Bald Eagle, but they will feed on reptiles, amphibians, crabs, and small mammals like rabbits and muskrats. They will also eat carrion and can occasionally be found on roadsides feeding on a dead deer.

At one point, the Bald Eagle was endangered by hunting and pesticides. It was rare to see a Bald Eagle in Illinois until the last 30 years. A very prominent bird across the United States, the eagle started to become rare in the mid-to-late 1900s due to trapping, shooting, and poisoning. Two major concerns were lead poisoning (lead from shooting other wildlife and the eagle eating it) and the poisoning by DDT a now banned pesticide that caused eggshells to grow thin and chicks not hatch. By 1978, the Bald Eagle was listed for protection under the Endangered Species Act. With protection,



the eagle population started to increase. Today, the global population is estimated to be more than 316,000. Lead poisoning is still a problem today as well as collisions with motor vehicles, and habitat destruction.

During winter, it can be easier to find Bald Eagles in Illinois as the northern populations move south to warmer climates and open waterways. Two great places to see eagles in Illinois in January/February

are at the Starved Rock Lock & Dam on the Illinois River near Utica and Lock & Dam 13 on the Mississippi River north of Fulton. On January 27-28, 2024, the Illinois Waterways Visitor Center, Starved Rock Visitor Center, and Starved Rock Lodge will be hosting Eagle Watch Weekend. The event will include outdoor eagle viewing, live raptor shows, and nature programs. Visit https://www.starvedrocklodge. com/event/eagle-watch-weekend-2/ for more details. If you won't be nearby for this event, check around your area to find other eagle weekend events!

Fun fact: Bald Eagles are powerful hunters with large, sharp talons. These talons have a grip of nearly 400 psi (pounds per square inch). In comparison, humans have a bite around 150 psi and lions/tigers are around 1,000 psi.


